Clinton Township residents/employees can submit all required paperwork starting at 8AM on June 3rd. Non-residents can submit all required paperwork starting at 8AM on June 10th.

- o Copy of driver's license or other proof of age
- o Copy of valid **2024** NJ Hunting License (BOW AND GUN IF APPLYING FOR A PROPERTY THAT ALLOWS BOTH)
- o Signed Certificate of Eligibility that no felony convictions or violations of local regulations pertaining to parks or hunting
- o Signed Release authorizing the Township Police Department to conduct a background check for violations of the NJ Fish and Game Code
- o Copy of a current certificate of insurance confirming general liability insurance with coverage with combined single limits for bodily injury and property damage of at least \$1 million per single occurrence and \$1 million dollars annual aggregate.
- o Current NJ Federation of Sportsmen's Club (or equivalent) membership card, if applicable

PLEASE REMEMBER THAT THE \$100 PERMIT FEE WILL BE COLLECTED AT THE ORIENTATION AFTER ALL TEAM MEMBERS HAVE ATTENDED. ALL TEAM MEMBERS MUST ATTEND ONE OF THE TWO ORIENTATION DATES PROVIDED. IF ALL TEAM MEMBERS DO NOT ATTEND YOU WILL NOT BE ASSIGNED A PROPERTY.
