#### **REPORTS**

<u>Report from Council</u> - Mr. Higgins reported that Council passed Resolution for the Bond for the Affordable Housing Plan. Attorney Drill reported that he submitted that to Judge Miller with a copy of a proposed final judgement of compliance and repose. Then we start development approval process on the various sites.

Attorney Drill also reported the following:

- An oil contamination issue was discovered at the Willows at Annandale site. To remedy the contamination, they will have to take down a huge beautiful tree. According to the ordinance, it will require a huge number of trees for replacement. It was suggested that rather than a large number of smaller trees, a smaller number of larger trees may be a better solution. It was decided to appoint a subcommittee for the Board Landscape Architect to consult with.
- Attorney Drill received a call from a reliable source today that there is a group that has organized itself in the state of NJ and they come into Municipalities, start videotaping everything and then submit a bunch of OPRA Requests. They showed up in Delaware Township, brought in their equipment in black bags. The Delaware Township Clerk pushed the panic button, they had a lock down and called the police. They went into Flemington and Raritan Township and started filming...the question is, do they have the right to do that and if so at what locations? Discussion ensued and Attorney Drill advised that the Township discuss this with the Township Attorney to determine where they are allowed to record.

<u>Report from Ordinance Committee</u> - It was decided that the Ordinance Subcommittee be reconstituted. Mr. Higgins reported that we have the County Land Use Study to review and it would be great to have someone from the Ordinance Subcommittee participate.

Report from Open Space – Scheduled to meet on January 24<sup>th</sup>.

Report from Environmental Commission - Mr. Higgins reported that they had a meeting and Andy Holt is the new Chairman. The Environmental Commission will be having a joint meeting with Open Space.
