REQUEST FOR EXTENSION OF TIME

CHABAD OF HUNTERDON COUNTY

The applicant is seeking a one-year Extension of the Time within which to obtain a Final Certificate of Occupancy.

Nicole Voight, Esq. representing the applicant, stated that they are here seeking a one-year extension to get their final certificate of occupancy. The applicants had separate council when they received their original approval. They have commenced construction and all that is left is the landscaping. There was a compliance report done and they are still not finished with the landscaping.

Mr. Drill reviewed the past two resolutions and read through the letter submitted by the applicant's attorney. He explained that tonight they are seeking a one-year extension of time to get their final CO, but they are preparing an amended plan to come back to the Board with regarding the landscaping and security issues.

Ms. Voight stated that there are security issues and concerns with the current landscaping plan after the new landscape architect and rabbi walked the property. They stated it took some time to figure out what this means and what to do and they are about ready to submit a revised plan but would like the extension of time.

Mr. Drill explained what is required to be met for a landscape exception since it is not a "c" variance.

Vice Chairman Higgins asked for the Board to approve the creation of a subcommittee to find a security expert to advise the Board. The Board agreed.

There was discussion about the amount of time to grant the extension for.

Mr. Drill stated the motion will grant the six-month extension of the permanent CO, six-month extension of the temporary CO, six months to submit the complete application to modify the landscaping, six months, continuation of the performance guarantee, and Mr. Higgins, Mr. McCaffrey and Mr. Aversa to be on the subcommittee to interview and recommend a security expert.

Ms. Kleinhans made a motion, and Ms. Butcher seconded, the approval of the extension as noted above, and the subcommittee and subcommittee appointees as noted above. Motion carried.
