New Business

Operator's Report

Mr. Parr reported all stations are operational, have been inspected weekly, data collected, and baskets cleaned. High level alarms were tested. Mr. Parr reported the following activities/issues:

- October 12th- 12 River Bend Rd., Called to report lower floor shower and toilet has been backing up. After further investigation by a NSU Operator it was determined that the issue was the responsibility of the resident
- October 16th- NSU received a power failure alarm from County 641. Power was restored in minutes no response needed from a NSU operator.
- October 17th– NSU received a pump 2 fail alarm at Maple Ave PS. The NSU operator was able to reset the pump after several attempts. NSU Services installed an old spare pump in the pump 1 position.

Mr. Parr additionally has provided a proposal from Natural Systems Utilities for the repair of Maple Ave PS Pump #1.

Maple Ave PS Pump #1. Pump #1 has been removed for diagnosis due to a seal failure alarm. Subsequent diagnosis has revealed a lower shaft seal leak, and water intrusion within the unit. NSU proposes to repair the existing unit. The cost of repair is \$6,875.00.

Chairman Krommenhoek moved, and Peter Geiger seconded the motion to accept the proposal from Natural Systems Utilities to repair Maple Ave PS Pump #1 for \$6,875.00. There being no further discussion, the roll was called.

Mr. Parr additionally has provided a proposal from Natural Systems Utilities for the repair or replacement Beaver Brook #1 PS Pump #2. Pump #2 has failed. The unit requires substantial repairs. Repair costs are slightly less than 50% of replacement for a total of \$7,254.50. The manufacture date is unclear, but the pump appears to be from 2013. Due to age and significant cost, NSU proposes to replace the pump unit with one exact replacement unit for a total of \$12,754.50.

Chairman Krommenhoek moved, and Mike Mauer seconded the motion to accept the proposal from Natural Systems Utilities to replace Beaver Brook #1 PS Pump #2 for \$12,754.50. There being no further discussion, the roll was called.
