PUBLIC HEARING NOTICE

TAKE NOTICE that the Clinton Township Sewerage Authority (CTSA) has filed a request with the New Jersey Department of Environmental Protection for funding through the New Jersey Water Bank for the proposed North Hunterdon Regional High School Pump Station Replacement Project. The proposed project involves the construction of a new submersible sewage pump station to replace the existing station in a location adjacent to the existing station. The improvement is needed to replace aged and worn equipment and facilities and to accommodate new connections to the CTSA system within its existing sewer service area. The project will also provide abatement to sewer system leakage (Infiltration and Inflow) within the school district's sewers that are upstream of the station. The construction will involve the installation of new below-grade pumping facilities and equipment. The existing one-story brick building and fiberglass shed will be rehabilitated and refurbished to house the new electrical and controls equipment for the station. To collect new incoming flow and direct it into the new station, that will emanate from an offsite residential development (affordable housing) and from a proposed "Vo-Tech" building to be constructed on the Regional High School campus, approximately 291 LF of new 8" gravity sewer will be installed upstream of the proposed station. The total estimated construction cost of the project is \$971,410 with a total cost of the project at approximately \$1.231 Million. The estimated project cost of \$1.231 Million will be funded by the New Jersey Water Bank.
