






Revenues

Key Revenue Impacts

- Surplus available \$1.55 million, an increase of \$766K from prior year.
- Surplus to be utilized: \$975K.
- COVID impact: reduced revenue from Court due to fewer sessions and a steep decrease in Interest Income.
- Construction Fees continue to decline due to a slowdown in large development projects.






Appropriations

Key Appropriation Impacts

- Total appropriations up only 0.92%.
- Increase in IT expense budget due to retirement.
- Increase in Public Works Salaries due to contractual salary increases.
- Increase in Road Repair & Maintenance for chip sealing to extend roadway life.
- Shift of salary from Clerk to Admin.
- Decrease in Debt Service (-\$114K) partially due to refinancing.



Capital Budget Plan

The capital projects and equipment below are anticipated to be undertaken in 2021:

- Grayrock, Fairview, Fuller Pl. and Fulper Alley Paving and partial reconstruction
- Hibbler and Stone Mill Roads Paving
- Public Works: F250 Truck and F450 Chassis (for use with existing dump body)
- Fire Department: SCBA Packs (complete replacement due to obsolescence ~ \$200K)
- Police Department: Various Equipment, including State mandated body cameras

The following capital projects and equipment were completed and/or purchased in 2020:

- Stanton Mountain Road Phase II Paving and partial reconstruction
- Herman Thau Paving
- Public Works Dump Trucks
- Fire Department Turnout Gear
- Police Vehicles




Open Space Budget Plan

The projects below are included in the 2021 Open Space budget:

- Environmental testing and cleanup at Prostak property.
- Finalization of remediation at Windy Acres.
- Creation of parking lots at Prostak and Windy Acres.
- Mowing of trails, parks and other open space.
- Disc Golf Course and Dog Park improvements.
- Replacement of trees at the Nassau/Springside property.
- Potential land acquisition.

Net Debt

- Net Debt reduced to \$18.245 million.
- Net Debt reduced by over \$5.4 million since 2018.
- In 2021, we refinanced \$7,068,000 of outstanding debt at a very low rate.
