

**ORDINANCE NO.**

**AN ORDINANCE TO AMEND ORDINANCE NO. 1130-19 ENTITLED “AN ORDINANCE TO ESTABLISH SALARIES, WAGES AND COMPENSATION RANGES FOR NON-CONTRACTUAL OFFICIALS AND EMPLOYEES OF THE TOWNSHIP OF CLINTON, COUNTY OF HUNTERDON, STATE OF NEW JERSEY”**

**ORDINANCE NO.**

**APPROPRIATING \$53,000 FROM THE CAPITAL IMPROVEMENT  
FUND FOR A POLICE VEHICLE AND EQUIPMENT BY THE  
TOWNSHIP OF CLINTON, IN THE COUNTY OF HUNTERDON,  
NEW JERSEY**

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWNSHIP OF CLINTON,  
IN THE COUNTY OF HUNTERDON, NEW JERSEY AS FOLLOWS:

Section 1. \$53,000 is hereby appropriated from the Capital Improvement Fund of the Township of Clinton, in the County of Hunterdon, New Jersey (the "Township") for the purchase of the following vehicle for the Police Department and further including all related costs and expenditures incidental thereto:

Police SUV and Equipment	\$53,000.00

Section 2. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 3. This ordinance shall take effect after final adoption and publication and otherwise as provided by law
