RESOLUTION ACCEPTING IMPROVEMENTS AND APPROVING REQUEST BY CHABAD OF HUNTERDON COUNTY FOR RELEASE OF PERFORMANCE GUARANTEE (BLOCK 90, LOT 2.15)

WHEREAS, the Township of Clinton is the beneficiary of a performance guarantee posted by Chabad of Hunterdon County in August 2018 in connection with development approvals granted by the Clinton Township Planning Board on February 5, 2018 for property located at 63 Payne Road and designated on the Clinton Township tax maps as Block 90, Lot 2.15; and

WHEREAS, the specific improvements for which the guarantee was posted are identified in a letter dated July 2, 2018 from then-Township Engineer Cathleen F. Marcelli, PE of Mott MacDonald (see Exhibit A attached hereto); and

WHEREAS, the total amount of the performance guarantee is \$116,856.00, of which \$105,170.40 was posted in the form of a performance bond issued by Unity Bank (Bond No. UB0001159) (see **Exhibit B** attached hereto), and the remainder was posted in cash; and

WHEREAS, Chabad of Hunterdon County has completed the installation of the bonded improvements and requested that the performance guarantee be released in full; and

WHEREAS, section 165-49E(3) of the Township Code states that the term of the maintenance guarantee shall be for a period not to exceed two years and shall automatically expire at the end of the established term; and

WHEREAS, on August 24, 2022, the Township Clerk received a report from Township Engineer Larry Plevier, PE/CME of Mott MacDonald, dated August 24, 2022, which report indicates that 100% of the bonded improvements have been installed as shown on the approved site plan and are complete and satisfactory (see Exhibit C attached hereto); and

WHEREAS, the Township Engineer has recommended that in light of the above, the improvements be accepted and the performance guarantee released in full, conditioned upon the posting of a two-year maintenance guarantee pursuant to section 165-49E of the "Code of the Township of Clinton" ("Code") and payment of inspection fees pursuant to section 165-49J of the Code; and

WHEREAS, no cause has been established to reject the completed improvements or withhold the performance guarantee; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Clinton in Hunterdon County, New Jersey as follows:

- 1. The findings set forth in the preamble to this resolution are hereby incorporated as if fully restated herein.
