## RESOLUTION

### REQUESTING APPROVAL OF ITEMS OF REVENUE AND APPROPRIATION AMERICAN RESCUE PLAN-LFRF- LOSS OF REVENUE

**WHEREAS**, N.J.S.A. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any county or municipality when such item shall have been made available by law and the amount was not determined at the time of the adoption of the budget; and

**WHEREAS**, the Director may also approve the insertion of an item of appropriation for equal amount.

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Council of the Township of Clinton, County of Hunterdon, State of New Jersey, hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the 2022 budget in the sum of \$464,500.00 under caption ARP-LFRF, Loss of Revenue broken down as follows:

FD Command Vehicle	\$75,000
Fire Safety Vehicle	\$50,000
Police Vehicle (2)	\$92,000
Speed Signs	\$7,500
Mill and Pave Petticoat and Allerton Roads	\$200,000
FD Fire Hose	\$40,000

**BE IT FURTHER RESOLVED** that the like sum of \$464,500.00 is hereby appropriated under the caption, ARP-LFRF-Loss of Revenue.

**ORDINANCE NO.**

**APPROPRIATING \$58,000 FROM THE CAPITAL IMPROVEMENT  
FUND FOR EQUIPMENT FOR THE DEPARTMENT OF PUBLIC  
WORKS WITHIN THE TOWNSHIP OF CLINTON, IN THE  
COUNTY OF HUNTERDON, NEW JERSEY**

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWNSHIP OF CLINTON,  
IN THE COUNTY OF HUNTERDON, NEW JERSEY AS FOLLOWS:

Section 1. \$58,000 is hereby appropriated from the Capital Improvement Fund of the Township of Clinton, in the County of Hunterdon, New Jersey (the "Township") for the purchase of the following equipment for the Department of Public Works and further including all related costs and expenditures incidental thereto:

20-Ton Tag Along Air Brake Trailer (Public Works)	\$35,000
Tow Behind Air compressor (Public Works)	\$23,000

Section 2. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 3. This ordinance shall take effect after final adoption and publication and otherwise as provided by law
