### **AUTHORIZING PAYMENT OF PLAINTIFF'S COURT COSTS AND ATTORNEY'S FEES IN LITIGATION FILED UNDER THE OPEN PUBLIC RECORDS ACT**

**WHEREAS**, Rise Against Hate is the prevailing party in litigation captioned *Rise Against Hate v. Clinton Township*, Docket No. HNT-L-170-22, which was filed on April 11, 2022 against the Township of Clinton ("Township") pursuant to the Open Public Records Act ("OPRA"), N.J.S.A. 47:1A-1 *et seq.*; and

**WHEREAS**, pursuant to OPRA and applicable case law, plaintiff as the prevailing party is entitled to recover its court costs and reasonable attorney's fees from the Township; and

**WHEREAS**, plaintiff's counsel has submitted a demand for court costs in the amount of \$324.76 and attorney's fees in the amount of \$1,905.00, for a total of \$2,229.76; and

**WHEREAS**, the Mayor and Council, having reviewed the invoices submitted by plaintiff's counsel and consulted with the Township Attorney, find the demand to be reasonable and therefore wish to authorize its payment as submitted;

**WHEREAS**, the Chief Financial Officer has certified that the necessary funds are available in the Current Operating Fund Account #01-201-20-155-220.

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Township of Clinton, as follows:

1. The preamble to this resolution is hereby incorporated as if more fully set forth herein.
