## **RESOLUTION**

### **RESOLUTION OPPOSING THE PROPOSED INCREASES TO THE STATE HEALTH BENEFITS PROGRAM**

**WHEREAS**, the State Health Benefits Program (SHBP), governed by N.J.S.A. 52:14-17.25 et seq., offers medical, prescription drug, and dental coverage to qualified State and participating local government public employees, retirees, and eligible dependents; and

**WHEREAS**, all SHBP plans are self-funded meaning that the money paid out for benefits comes directly from a SHBP fund supplied by the State, participating local employers, and member premiums; and

**WHEREAS**, the Division of Pensions and Benefits is responsible for the daily administrative activities of the SHBP, the State Health Benefits Commission is the executive organization responsible for overseeing the SHBP; and

**WHEREAS**, the State Health Benefits Commission, comprised of state officials and union representatives, annually consider the calendar year premium levels for the Local Government Employer Group of the SHBP based on recommendations found in the Rate Setting Recommendation Analysis of the Local Government Employee Group; and

**WHEREAS**, the preliminary rate increase for the 2023 Local Government Employer Group is 22.8%, which includes a 21.6% increase for Active, a 13% increase in Early Retiree, and a 0.7% increase for Medicare Retiree; and

**WHEREAS**, subsequent news accounts has Department of Treasury noting “rates for active members and early retirees would likely be increase between 12-20% across the various plans for the upcoming year”; and

**WHEREAS**, such proposed exorbitant rate increases will fall upon the local property taxpayer along with the local public employees at a time where there is record inflation, and

**WHEREAS**, the proposed premium increase for most active employees will take thousands more out of their paychecks annually and lead to huge costs for local governments that will translate into higher property tax bills for struggling families; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Clinton in the County of Hunterdon call up the State Health Benefit Commission to reconsider the rate increase and strike a rate increase that is appropriate in the current economic conditions; and

**BE IT FURTHER RESOVLED**, that the Mayor and Council of the Township of Clinton in the County of Hunterdon urge the legislature to adopt legislation expanding the composition of the State Health Benefits Commission to include representatives from both municipal and county government management; and

**BE IT FURTHER RESOLVED** that a copy of this resolution be forwarded to Governor Murphy, State Treasurer Muoio, Senate President Scutari, Assembly Speaker Coughlin, Senator Michael Doherty, Assemblyman John DeMaio, Assemblyman Erik Peterson and New Jersey State League of Municipalities.

## RESOLUTION

### RESOLUTION AUTHORIZING 2022-2023 SHARED SERVICES AGREEMENT WITH THE CLINTON TOWNSHIP SCHOOL DISTRICT BOARD OF EDUCATION FOR LAW ENFORCEMENT OFFICER

**WHEREAS**, various New Jersey state statutes governing municipalities encourage and permit a variety of shared services, consolidated, and regional services; and

**WHEREAS**, in 2007, the New Jersey legislature adopted the “Uniform Shared Services and Consolidation Act,” N.J.S.A. 40A: 65-1 et seq., to create a new shared services statute to effectuate agreements between local units for any service or circumstance intended to reduce property taxes through the reduction of local expenses and to effectuate agreements between local units for any service or circumstance that any party to the agreement is empowered to provide within its own jurisdiction; and

**WHEREAS**, the Clinton Township School District Board of Education (“School District”) and the Township of Clinton (“Township”) desire to enter into a shared services agreement through which the Township will assign of a police officer to the School District on a full-time basis to serve as a school resource officer; and

**WHEREAS**, the School District and the Township recognize the potential benefits to the students and staff of the School District and the citizens of the Township to have a school resource officer assigned to the School District’s three schools to provide for the safety and security of all persons during regular school hours, and where feasible, to assist the School District staff in providing assistance with programs that promote a safe school environment; and

**WHEREAS**, it is in the best interests of the School District and the Township to enter into this agreement.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Township of Clinton in Hunterdon County, New Jersey as follows:

1. The preamble to this resolution is hereby incorporated as if more fully set forth herein.
2. The Council hereby approves a one-year shared services agreement with the Clinton Township School District Board of Education to provide one full-time police officer to the School District to serve as a school resource officer under the following terms and conditions:
  - a. The Township will assign one officer to serve in all three Clinton Township schools, Clinton Township Middle School, Round Valley School, and Patrick McGheran School, on days when school is in regular session, up to forty hours per week during the school year.

- b. The officer shall be selected by the Township Chief of Police in consultation with the School District.
  - c. The officer will remain an employee of the Township.
  - d. The officer shall successfully complete training for safe school resource officers in accordance with New Jersey state law.
  - e. All specific duties of the school resource officer shall be assigned through the Clinton Township Police Department's chain of command in cooperation with the Superintendent of School or the Superintendent's designee.
  - f. The primary function of the school resource officer is to provide for the safety and security of all persons (students, teachers, staff, parents, contractors, etc.) on school property during regular school hours. Where feasible, the officer will work collaboratively with the district and other agencies to create safe and drug-free schools and promote healthy youth development.
  - g. The officer shall not act as a school disciplinarian.
  - h. The School District agrees to pay the Township an amount not to exceed \$95,000.00 for the provision of services from August 29, 2022 through June 30, 2023.
3. The Township Administrator and Township Attorney are hereby authorized and directed to prepare a one-year shared service agreement incorporating the terms contained herein, and the Mayor and Clerk are hereby authorized and directed to execute such agreements once approved as to form and content by the Township Attorney.

**ORDINANCE NO.**

**AN ORDINANCE OF THE TOWNSHIP OF CLINTON IN HUNTERDON COUNTY, NEW JERSEY, AMENDING CHAPTER 165 (LAND USE REGULATIONS) OF THE “CODE OF THE TOWNSHIP OF CLINTON” BY MODIFYING THE DEFINITION OF “DWELLING OR DWELLING UNIT” SET FORTH THEREIN**

**BE IT ORDAINED** by the Mayor and Council of the Township of Clinton, in Hunterdon County, New Jersey as follows:

**Section 1. Chapter 165 of the “Code of the Township of Clinton” amended to modify the definition of “dwelling or dwelling unit” set forth therein.** Section 165-4, “Definitions” in Chapter 165, “Land Use Regulations” of the “Code of the Township of Clinton” is hereby amended by replacing the current definition of “dwelling or dwelling unit” set forth therein with the following new definition:

**DWELLING or DWELLING UNIT**

A room or series of connecting rooms designed for permanent residency and containing living, cooking, sleeping and sanitary facilities for one housekeeping unit. The dwelling unit shall be self-contained and shall not require passing through another dwelling unit or other indirect route(s) to get to any portion of the dwelling unit, nor shall there be shared facilities with another housekeeping unit.

**Section 2. Repealer.** All ordinances and resolutions or parts thereof inconsistent with this ordinance are hereby repealed as to such inconsistencies only.

**Section 3. Severability.** If any paragraph, section, subsection, sentence, sentence clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court or administrative agency of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision of such holding shall not affect the validity of the remaining paragraphs or sections hereof.

**Section 4. Referral to Planning Board.** Pursuant to the Municipal Land Use Law, *N.J.S.A.* 40:55D-64, a copy of this ordinance will be referred to the Clinton Township Planning Board for review prior to its adoption.

**Section 5. Effective date.** This ordinance shall take effect 20 days after its final passage and the filing of same with the Hunterdon County Planning Board, all in accordance with law.

### AN ORDINANCE OF THE TOWNSHIP OF CLINTON IN HUNTERDON COUNTY, NEW JERSEY, MODIFYING THE STORMWATER MANAGEMENT REQUIREMENTS FOR MINOR DEVELOPMENTS AND AMENDING CHAPTER 165 (LAND USE REGULATIONS) OF THE “CODE OF THE TOWNSHIP OF CLINTON”

**BE IT ORDAINED** by the Mayor and Council of the Township of Clinton, in Hunterdon County, New Jersey as follows:

**Section 1. Chapter 165 of the “Code of the Township of Clinton” amended to modify the stormwater management requirements for minor developments.** Section 165-229, “Stormwater Management Requirements” in Chapter 165, “Land Use Regulations,” Part 8, “Flood Hazard Areas and Surface Water Management,” Article XXXV, “Surface Water Management” of the Code of the Township of Clinton is hereby amended to read as follows (new text is underlined thus; deleted text is in brackets [thus]):

#### **§ 165-229. Stormwater management requirements for minor development.**

Minor developments. Minor developments shall be designed to include the following stormwater management measures:

1. Water quality. Soil erosion and sediment control measures shall be installed in accordance with the Standards for Soil Erosion and Sediment Control in New Jersey.
2. Rate/volume control. Seepage pits or other infiltration measures shall be provided with a capacity of [three]one inch[es] of runoff for each square foot of new impervious area. Stone used in the infiltration devices shall [be]range from three-quarter-inch to two-and-one-half-inch clean stone and a design void ratio of [33%]forty percent shall be used. The infiltration measures shall be designed with an overflow to the surface which shall be stabilized and directed to an existing stormwater conveyance system or in a manner to keep the overflow on the developed property to the greatest extent feasible. If the new impervious surface is not roof area, an equivalent area of existing roof may be directed to the infiltration system. This shall be permitted where the existing roof is not already directed to infiltration devices.
3. Location of infiltration measures. Stormwater infiltration measures, such as dry wells and infiltration trenches, shall be

horizontally separated from existing and/or proposed potable wells and subsurface sewage disposal fields and existing septic seepage pits or cesspools in accordance with Table 4.3 of N.J.A.C. 7:9A-4.3, or latest amended or revised edition.

4. Relief from requirements. The Township Engineer may reduce or eliminate the infiltration measures required by subsection 165-229A(2) above if in his or her professional judgment based on sound engineering principles, reasonable cause exists to do so.

**Section 2. Repealer.** All ordinances and resolutions or parts thereof inconsistent with this ordinance are hereby repealed as to such inconsistencies only.

**Section 3. Severability.** If any paragraph, section, subsection, sentence, sentence clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court or administrative agency of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision of such holding shall not affect the validity of the remaining paragraphs or sections hereof.

**Section 4. Referral to Planning Board.** Pursuant to the Municipal Land Use Law, *N.J.S.A.* 40:55D-64, a copy of this ordinance will be referred to the Clinton Township Planning Board for review prior to its adoption.

**Section 5. Effective date.** This ordinance shall take effect 20 days after its final passage and the filing of same with the Hunterdon County Planning Board, all in accordance with law.
