**AN ORDINANCE OF THE TOWNSHIP OF CLINTON IN HUNTERDON COUNTY, NEW JERSEY, ESTABLISHING SALARIES, WAGES, AND COMPENSATION RANGES FOR NON-CONTRACTUAL OFFICIALS AND EMPLOYEES**

**BE IT ORDAINED**, by the Mayor and Council of the Township of Clinton, County of Hunterdon, State of New Jersey as follows:
