AN ORDINANCE OF THE TOWNSHIP OF CLINTON IN HUNTERDON COUNTY,
NEW JERSEY PROHIBITING OVERNIGHT PARKING ON MUIRFIELD LANE,
GLENEAGLES DRIVE AND HEATHER HILL WAY, AND AMENDING CHAPTER 7 OF
THE "CODE OF THE TOWNSHIP OF CLINTON" ENTITLED "TRAFFIC"

BE IT ORDAINED the Mayor and Council of the Township of Clinton, County of Hunterdon, State of New Jersey, as follows:

SECTION 1. Amendment to list of streets on which parking is prohibited during certain hours. Section 7-14 ("Parking prohibited during certain hours on certain streets") of the "Code of the Township of Clinton," is hereby amended and supplemented by adding additional streets and times during which parking is prohibited thereon as follows (new language is underlined thus):

§7-14. Parking prohibited during certain hours on certain streets.

No person shall park a vehicle between the hours specified any day (except Sundays and public holidays) upon any of the streets or parts of streets described:



SECTION 2. Repealer. All ordinances and resolutions or parts thereof inconsistent with this ordinance are repealed.

SECTION 3. Severability. If any paragraph, section, subsection, sentence, sentence clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court or administrative agency of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision of such holding and shall not affect the validity of the remaining paragraphs or sections hereof.

SECTION 4. Effective date. This ordinance shall take effect 20 days after final passage in accordance with N.J.S.A. 40:69A-181.

The purpose of the ordinance is to prohibit parking during the hours of 10 p.m. to 6 p.m. daily on the entire length of both sides of Muirfield Lane, Gleneagles Drive and Heather Hill Way.
