### REPORTS FROM MAYOR AND COUNCIL MEMBERS

Councilman Glaser reported that the Planning Board meeting will be held on February 4<sup>th</sup> and there will not be a meeting in January due to the Holiday. The New Jersey League of Municipalities held a luncheon and discussed the affordable housing bills that are to be considered at the committee level in the coming days. The Sewage Authority is scheduled to have their re-organization meeting on February 8 at 8 AM. The Finance Committee is preparing for the budget and the 2023 Annual Debt Statement was finalized with nearly a \$1 million reduction in Net Debt. There are meetings to be scheduled with the Administrator, C.F.O., and staff for the 2024 budget.

Councilman Kochanowski echoed Councilman Glaser with the Finance Committee report and commented that the Net Debt is good news, and we would like to be where the County is regarding their debt level.

Councilwoman Switlyk asked about an Ordinance for bamboo throughout the Township and wanted to know the Council's feedback on this. Mayor Mullay mentioned that he hasn't heard of any complaints yet regarding this, and asked who would enforce the Ordinance. The Environmental Commission and North Hunterdon High School Environmental Club will be working with each other for 2024. The Green Team is applying for grants and hoping to attain the Bronze level for the Township. The hunting program is

looking to start the yearly process earlier this year and hoping to get an ad in the newsletter for the Township. Mike Aversa, from the Township's Open Space Committee, commented on the hunting program and updates with the program and teams.

Ms. Cecil recused at 7:14 pm.

Councilwoman Switlyk reported on the recent correspondence with the Hunterdon County Land Trust and new funding ideas with parcels in the township and assistance with Green Acres.

Ms. Cecil reconvened at 7:17 pm.

Council President Strauss received the Historical Preservation Commission 2024 agenda items and goals for the Commission. The next meeting is scheduled for February 7<sup>th</sup>. Public Safety reports have been received by the Departments, and a meeting with the Fire Chief is to be scheduled. The CERT Member List is on tonight's agenda for approval by the Council and their 2023 report was received and shared with the Council.

Mayor Mullay reported on personnel matters and vacancies being filled hopefully within the next few weeks at the Municipal Building and the Police Department. The leaf collection and Christmas tree drop off were successful. Administrator Close added that the DPW Director gave the report of the drop off earlier this month and that goat farms were looking for old Christmas trees as well. Councilman Glaser suggested reaching out to HOA's in the Township for Christmas tree drop off and Mr. Close mentioned that the DPW Director is thinking about a location change for the drop off site. Councilman Kochanowski asked about a mulcher and if the Township purchases mulch.

Administrator Close commented on the elevator issue at the Public Safety building and the resolution on the agenda for an increase in amount for the elevator repair due to an unseen change. He's hopeful for the elevator repair to be completed by Friday and the claim is going through the Joint Insurance Fund. The meetings in the building have been within ADA compliance as well through a TV being placed in the room on the first floor for the public to view the meetings.

Mayor Mullay commented on Recreation Committee items and updates. Community Day, Easter Egg Hunt, and the grant for the inclusive playground were mentioned at their last meeting.

Chief DeRosa mentioned that they are prepping for National Night Out and the junior Police Academy. Chief DeRosa gave an update on the accreditation program and the destruction of evidence. There will be a policy review as well for the Police Department. Mayor Mullay asked about Officer Akers at the middle school and Chief DeRosa said that everything is going well, but there are concerns for the North Hunterdon Voorhees Board of Education meetings, with the Board requesting two more officers on meeting nights. The Special Officers are doing great as well.

### **PUBLIC HEARING**

 State of New Jersey Green Acres Program for improvements at Runkle Drive Park, in the Township of Clinton, to create an inclusive playground at the site of Runkle Drive Park.

Mayor Mullay spoke about the \$750,000.00 competitive grant for an inclusive playground. There isn't a concept plan yet, but the Public Hearing is required for the grant application. Mr. Close went through the process of the grant application steps that would be needed for this grant. Mayor Mullay mentioned that this would be an ADA compliant and inclusive playground for the Township. Mr. Close mentioned that there will be other grants as well to come for playground rehabilitation and rebuilding.

There were no comments from the Public.

The Council voted on Resolution 2024-43 and Council President was recused.

RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF CLINTON RECOGNIZING THE NORTH HUNTERDON FIRE ALLIANCE AND AUTHORIZING REIMBURSEMENT FOR CERTAIN EXPENSES

WHEREAS, the Municipalities of Borough of High Bridge, Borough of Lebanon, Town of Clinton, Township of Clinton, and the Township of Franklin, in Hunterdon County, New Jersey, are each protected by their own municipal fire departments or companies, consisting of the Borough of High Bridge Fire Department, the Borough of Lebanon Fire Company, the Town of Clinton Fire Department, the Township of Clinton (Division of Fire) Annandale Hose Company #1, and the Franklin Township Fire District #1 (Quakertown Fire Company), respectively (collectively, "the fire companies"); and

WHEREAS, the fire companies routinely through mutual aid respond to fire and emergency calls within all five communities; and

WHEREAS, the fire companies operate under common operational guidelines and training levels; and

**WHEREAS**, the fire companies wish to continue to support one another with manpower, equipment and apparatus through an informal alliance known as the North Hunterdon Fire Alliance, with personnel and equipment stationed in their various facilities, in order to further enhance response times and the mutual aid they already provide within the five municipalities reference above:

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Township of Clinton, County of Hunterdon, State of New Jersey as follows:

1. The Mayor and Council hereby recognize and support the North Hunterdon Fire Alliance serving in cooperation and sharing their five respective fire houses from time

to time to provide fire and emergency service within the jurisdiction of the named municipalities.

In support of the Alliance's efforts, the Mayor and Council hereby authorize the Township's Chief Financial Officer to reimburse Annandale Hose #1 for dinner/food costs (excluding taxes) in an amount not to exceed \$100.00 on its assigned weekend(s) of coverage.

Councilman Kochanowski motioned to approve Resolution 2024-43; Councilman Glaser seconded.

**WHEREAS**, the Township of Clinton ("Township") requires professional accounting services during calendar year 2024, including but not limited to the preparation of the Township's fiscal year 2023 audit and other matters; and

WHEREAS, Warren Korecky of Suplee, Clooney & Company ("CONSULTANT") has offered to provide the needed services for a not-to-exceed cost of \$35,000; and WHEREAS, the Township wishes to enter into a professional services agreement ("Agreement") with CONSULTANT for the provision of professional auditing services as described above; and

WHEREAS, the Township has a need to acquire these services without a "fair and open process" as defined by P.L. 2004, c.19, the "Local Unit Pay-to-Play Law" and in connection therewith, CONSULTANT has completed and filed with the Township the required Campaign Contributions Affidavit pursuant to N.J.S.A. 19:44A-20.8 and Certification Regarding Political Contributions pursuant to N.J.S.A. 19:44A-20.26; and WHEREAS, the term of the Agreement shall be for one year, beginning on January 1, 2024 and ending on December 31, 2024; and

WHEREAS, the Local Public Contracts Law, N.J.S.A. 40A:11-5(1)(a)(i), authorizes the

Township to award this agreement as a professional services agreement, without public bidding;

**WHEREAS**, the Chief Financial Officer has certified that sufficient funds are available to pay for said services; and
