THE TOWNSHIP OF CLINTON WOULD LIKE TO REMIND YOU THAT:

- 1. IT IS UNLAWFUL FOR ANY PEDDLER, SOLICITOR OR CANVASSER, TO PEDDLE, SOLICIT OR CANVASS WITHIN THE TOWNSHIP WITHOUT FIRST HAVING OBTAINED A LICENSE § 204-3.
- 2. PEDDLING, SOLICITING OR CANVASSING AT ANY PROPERTY LISTED ON THE "DO-NOT-SOLICIT REGISTRY" OR ANY PROPERTY WITH A SIGN OF "NO SOLICITATION" SHALL CONSTITUTE A VIOLATION OF THIS CHAPTER AND SHALL BE GROUNDS FOR REVOCATION OF SUCH PERSON'S LICENSE § 204-10A(1), § 204-11.
- 3. IT SHALL BE UNLAWFUL FOR A PERSON TO REFUSE TO LEAVE A PRIVATE DWELLING OR PROPERTY AFTER HAVING BEEN ONCE REQUESTED TO DO SO BY THE OWNER OR OCCUPANT THEREOF § 204-11.
- 4. PEDDLER/SOLICITORS APPLICATIONS GO THROUGH A BACKGROUND CHECK AND IT CAN TAKE **UP TO 14 DAYS*** BEFORE INVESTIGATION IS COMPLETED.
- 5. A LICENSE CAN ONLY BE ISSUED ONCE A BACKGROUND CHECK HAS BEEN DONE AND THE APPLICATION HAS BEEN APPROVED.
- **BEFORE YOU SUBMIT A SOLICITORS/PEDDLERS APPLICATION MAKE SURE
 YOU HAVE APPLIED FOR IT WITH AMPLE TIME BEFORE THE START DAY YOU
 ARE REQUESTING. **

INFORMATION REQUIRED WITH THE PEDDLER/SOLICITOR LICENSE APPLICATION:

- 1. Two passport size [2x2] photos of each applicant.
- **2.** Copy of valid driver's license or State ID. (other acceptable documents: US passport, Alien registration card, County ID, Military ID)
- **3.** License fees are per person: \$50.00 annually or \$15.00 daily, cash or check made payable to Township of Clinton.
 - Fee exempt: any person with an honorable discharge from US military or fireman or volunteer fire dept. possessing a license.
- 4) Each application must be notarized in front of a notary.
- 5) If the applicant is a business, attach a letter of authorization and a separate application for each of the peddlers, solicitors, or canvasser to act on behalf of the business and attach a copy of certificate of authority from STNJ to collect sales tax (chapter 274, 1993) (transit merchants).
