Properties

Windy Acres – Bees will be going in during May timeframe, Need signage, fencing and electric fencing, Mushrooms will be going in but need oak logs in the 6-8 inch diameter size

ProstakEast – Trails need to be better identified and marked properly

Prostak West – Nothing to note

Hacketts – Les G to speak with local resident, Glenn Boyd re the monitoring of the trails, There is a refrigerator that was disposed of on one of the trials and this needs to be removed

Brays – Issue with resident, their chair has been removed and the trail they cut in has been blocked but we need to improve upon this

Cramer's Creek - Need to address location of 5K and fitness trail as impacted by the new playgroud and parking area, Les G will pull together a committee to meet at CC and address, Also includes when signage should be placed

BBR – There are a number of trees in the brook which could impact the bridge on Herman Thau Rd, Add to list of things to be addressed by DPW, June 9th will be historic hike

Springside – Trails are in good shape, nothing else to note

Eton Ct – Needs sigange and posting, Amy S mentioned speaking with Bill Glaser and it was recommended that all residents within 200 feet of an OS property to receive a letter detailing the rules of our OS properties

Possible Acquisitions – Disussed in detail as to status
