Hacketts – Residents complained that farmer sprayed crops but did not out sign up (See Above), There is a small refridgerator off the trial, Need DPW to remove it. If they don't get to it suggestion was to have the hunters remove it in the fall.

Brays – There was some storm damage from the stoem we had this week. Dpw to address

Cramer's Creek - Need to order parts and supplies for tee pads, Ben H as already provided a detailed list of what was needed. It was agrred that volunteers could do the install per conversation with Jay M, Brian M and Mike A., Tom S will address status of order. Will need a small kiosk for 5K trail

BBR –Per Mike M foot traffic has been good and no problems noted, Discussed possible parking on David Post and Herman Thau, Group decided that this was not a good idea.

Eton Ct – Property need to be posted as certain residents are utilizing OS property as their own.

General – It was suggested to do a mailing to all property owners within 200 feet of OS space property detailing the rules related to OS properties
