New Business

Operator's Report

Mr. Parr provided a written report. The following activities/issues were reported:

➤ Pump Station Activities

 All stations are operational. The stations have been inspected weekly, with data taken and baskets cleaned. All pump station high level alarms were tested for the month.

- 4/15 NSU Services installed the new Waters Edge PS P2.
- 4/19 NSU operator met with Rapid Pump and Meter to inspect all Waters Edge PS air release and flush manholes.
- 4/30 Pumping Services perform the pump inspections and install the new spare pump at Hamden Road PS. Early evaluation determined that both pump impellers had hair line cracks and P2 had excessive wear on the wear ring. Final evaluation to follow.
- ➤ Pump Station Issues
 - 4/26 Deer Meadow PS P2 VFD was tripping out. NSU Services pulled the pump and removed rags from the pump volute.
 - 4/26 Deer Meadow PS building exhaust fan would not run. NSU Services replaced the belts but there is some unusual noise while running. The exhaust fan may need to be replaced. We will monitor.
- ➤ Collection System Activities
 - 4/24 NSU operations pumped out the Clinton Woods FM air release and flush manholes for inspection.
- ➤ Alarms
 - None

- Additional Items

- Mark Outs
 - 181 total mark out requests received.
 - 35 requests were in the service area.
 - 1 request required an in-field mark out.

A brief discussion ensued regarding the Natural System's Utilities pumping out the Clinton Woods force main air release and flushed manholes on April 14, 2024. It was recommended that Clinton Woods post a maintenance bond, since only Clinton Township was on the performance bond. Mr. Ruschke will make sure the maintenance bond is posted before signing off on the CO.

Additionally, Mr. Parr received the videoing and inspection of Beaver Ave and Grayrock Road from Russel Reid. Both areas appear structurally fine. There is a known "bellying" on Beaver Ave that gathers debris, and it was cleaned during the line inspection.

2024 Pump Station Lawn Care Proposals

Ms. Paulus sought three proposals for 2024 pump station lawn care maintenance. Balaney Contracting LLC provided a proposal of \$650.00 per month, which is the same price as last year. Samson Concrete & Masonry, LLC declined to provide a proposal. 96 Landscape provided a proposal of \$625.00 per month.

Katrin Glode-Sethna moved, and Chairman Krommenhoek seconded a motion to accept the proposal of Balaney Contracting LLC in the amount of \$650.00 per month for 2024 pump station lawn care maintenance. There being no further discussion, the roll was called.
